UPDATE: 2022-2025 Facilities Collective Agreement – Changes Affecting Benefits

In follow up to the e-flash that was sent February 6, 2023, HBT is updating the request for information.

We have re-evaluated the scope of work involved by all parties to provide the updated earnings information. To make the task less onerous, Canada Life will instead send a list of the affected LTD employees who are affected by the wage increase.

General Wage Increases and Employees on Long Term Disability - UPDATED

- 1. The LTD benefit for employees disabled on or after April 1, 2022 are affected if they receive a retroactive wage adjustment.
 - Canada Life will provide you with a list of affected employees. You can expect to receive this by Feb 28, 2023 if you have any impacted employees.
 - Review the *Employer's Statement* and/or *Calculation of Part-Time Earnings* form(s) submitted for these employees.
 - If the reported pre-disability earnings have changed, send a <u>revised</u> *Employer's Statement* and/or *Calculation of Part-Time Earnings* form to Canada Life by March 17, 2023. Please send to Andy Mak at <u>Andy.Mak@canadalife.com</u>
- 2. Employees working Rehabilitation Employment **who were being paid by the employer for hours worked** are affected if they receive a retroactive wage adjustment. Canada Life has no ability to determine who these employees are and will rely on the employers to determine the employees affected.
 - Review the Monthly Earnings Report While on LTD form submitted.
 - If the reported rate of pay by the employer has changed, you must submit a <u>revised</u> Monthly Earnings Report While on LTD form to Canada Life by March 17, 2023.

- 3. Employees being assessed under Any Occupation are affected if they receive a retroactive wage adjustment.
 - Provide the Current Rate of Pay to Canada Life by March 17, 2023.
